\_\_\_\_\_ **Student Pick Up:** The Red Barn Youth Center operates normally from 2:30-6:00pm. Parents agree that they will have their child picked up **no later than 6:00pm**. We follow the school calendar and are open on days the school is open. **Summer hours are from 8am until 4:30pm**. Red Barn staff are not able to transport students. Please ensure transportation arrangements are made in advance.

\_\_\_\_\_ **Drop-in Policy:** I understand members are free to come and go as they please; staff/volunteers do not grant youth permission to leave, nor do we insist that they stay. **Arrival and departure is a matter strictly between the parent/guardian and child**. Once a child signs out for the day, they cannot return that day unless they have permission.

\_\_\_\_\_ **Internet Consent:** I give permission to the Red Barn Youth Center to provide my child internet access from the RBYC's Wi-Fi and computers. I understand the purpose of internet access is to enhance education, culture, recreation and competency in an information-driven society. I understand my child will lose internet privileges if it is deemed necessary by the RBYC due to inappropriate behavior. As the parent, I understand I can withhold my permission for them to access internet at any time.

## RULES AND EXPECTATIONS

- 1. Be respectful of the Red Barn.**

- 2. Be considerate of others.**  
Resolve conflict peacefully, without verbal or physical fighting.
- 3. No Bullying**  
If you experience it. Report it. We will stop it.
- 4. No public display of affection (P.D.A.)**  
P.D.A. is defined as hand-holding, extended hugging, kissing, and arms around/ on bodies.
- 5. No profanity**
- 6. No use or possession of alcohol/drug/tobacco/tobacco related products/electronic cigarettes.**
- 7. No articles of clothing which promote/display/contain/insinuate any of the follow in picture expression, symbol, or word information:** discrimination, gang related, profanity, violence, sex, alcohol/drug/tobacco related products
- 8. Keep hands, feet, and object to self.**
- 9. Report vandalism and bullying to staff**
- 10. Pick up trash and clean up after yourself! Garbage in the garbage, recycle in the recycle.**
- 11. Respect one another's privacy. Honor the personal space and property of others.**
- 12. Follow guidelines for computer use.**

## Discipline Policy

The Red Barn Youth Center strives to keep the consequences for unacceptable behavior clear, appropriate and timely. The safety of all members is of utmost importance to us. Our standards, along with the expectation that all students use good common sense, exist to ensure that your child and every other child at the RBYC can safely enjoy the RBYC. Any student who disrupts programs or creates a dangerous situation will be disciplined appropriately. Students who do not follow rules can expect to lose privileges and face consequences. Parents will be called to remove any student who has failed to curb their behavior and/or is behaving in an aggressive or violent manner that creates a dangerous situation.

**Minor Offenses:** Program staff may draw from a range of methods to establish what will work for each individual student. Examples may include, but are not limited to: Time-outs, restriction from activity or program area and/ or apology letters. Minor offenses include, but are not limited to : swearing, running inside, being in an unsupervised area and general horseplay.

**Major Offenses:** Program staff have the latitude to immediately suspend a student's participation. In case of immediate suspension, parents will be called and expected to pick the student up as soon as possible. A long term suspension may be imposed for repeat offenders or any student that is deemed dangerous to themselves, other students and/or staff. The student, their parents and RBYC staff will meet prior to the return of the student to the RBYC. Our goal is to work with student and their family as much as possible.
